Sub: M.PHARMACY COURSE -Introduction of Sessionals (Internal Assessments) in M. Pharmacy Course - Approved modalities for implementation from the academic year 2011-2012 and onwards - Communicating of.

Ref: Letter dated 13/03/2012 of the Chaiman, Board of Studies in Pharmaceutical Sciences, KU

I am to inform you that on the recommendation of the BOS in Pharmacy the Standing Committee of the Academic Senate at its 4th meeting held on 17th March 2012 decided to introduce sessionals (Internal Assessments) in M.Pharmacy courses from the academic year 2011-2012 and onwards.

Further, after threadbare discussions on the modalities submitted by the Board of Studies, it is resolved to authorize the Vice-Chancellor to take final decision in fixing the sessional marks by examining and comparing with pattern of sessional marks existing in other Universities in A.P. The Vice-Chancellor, after carefully examining the issue from all the dimensions and practices prevailing in neighboring sister Universities particularly Osmania University, Hyderabad has accorded approval to the following modalities in introducing the sessional marks (Internal Assessments) in M.Pharmacy Course for implementation to the batch of students admitted to the I year course for the academic year 2011-2012.

- 1. There shall be 30 marks for sessionals and 70 marks for semester (University examination) of both theory and practical papers of M.Pharmacy I & II Semester.
- 2. There will be no assignments in I &II Semesters from the academic year 2011-2012 onwards.
- 3. Two sessionals will be conducted in each subject of the theory for 30 marks each and average of the marks secured in the two sessionals shall be taken into account as the marks secured in the subject. In each sessional about 50% of the syllabus shall be covered.
- 4. Duration of the sessional exam shall be for 1 ½ hours (90 minutes). There shall be four (4) questions and students have to answer any three (3) of them. (There will be no internal choice in any of the questions)
- 5. Practical sessional examination for 30 marks shall be conducted at the end of course work of the Semester.
- 6. Minimum marks for passing in the Semester exam shall be 40% i.e., 28 marks out of 70 marks both in theory and practicals of M.Pharm I and II Semester examination. However, the candidate has to secure a minimum of 50 marks out of 100 (sessional and semester put together) in each theory and practical papers
- 7. The list of the qualified teachers (along with their CV), who evaluate the sessionals shall be sent to the Chairman, Board o Studies in Pharm. Sciences, at least two weeks before the commencement of the sessional exams.

- 8. All the affiliated colleges shall send the list of sessional marks secured by the students to the Chairman, Board of Studies in Pharamaceutical Sciences for onward submission to the Controller of Examinations subject to the moderation of marks by the Chairman, Board of Studies.
- 9. There is **no change** in the scheme and pattern of examination in the M.Pharm. III and IV Semester examination.
